# Annual Meeting of the Windham Association, Connecticut Conference, United Church of Christ May 22, 2018

Authorized Ministers, delegates and friends of the Windham Association gathered on May 22, 2018 at 6:00 p.m. at the East Woodstock Congregational Church. Following a potluck supper, the Rev. Rick Haverly called the meeting to order at 6:50 p.m. and led the assembly in prayer.

A quorum was established with representation from 12 of the Association's 18 congregations.

There was a motion by Mr. Kevin Williams and a second by the Rev. Paul Doyle to accept the **minutes** of the June 2017 annual meeting. Upon voting, the motion PASSED.

The **Treasurer's report** was presented by the Rev. Paul Doyle, who highlighted a few items and expressed thanks for the faithfulness of our local congregations, which has allowed us to meet many needs throughout the year. There was a motion by Ms. Emily Logee-Savoie and a second by the Rev. Cheryl Caronna to accept the report. Upon voting, the motion PASSED.

The Registrar's report was presented by Ms. Deborah Hubbell. The Rev. Matthew Emery noted that the Rev. Dr. Greg Gray's status had changed from Designated Term Pastor to Settled Pastor. Ms. Hubbell reported that, because of the timing, this would be reflected in next year's report. Rev. Emery introduced MID Ms. Kate Alexander to the assembly. The Rev. Jane Newall introduced herself as new to the Association and subsequently moved to accept the report. There was a second by Mr. Williams. Upon voting, the motion PASSED.

Rev. Haverly summarized the **Moderator's report** that was in the meeting packet and thanked the Rev. Joe Blotz for his service as the previous Moderator.

As Eastern Regional Minister, the Rev. Dr. Thomas Clough brought greetings from the Connecticut Conference and his final report to the assembly in this capacity since he will be retiring in June. He reflected on his career in general and particularly on his seven years as Eastern Regional Minister. He thanked the Association Council for its work and announced that the Rev. Chuck Ericson has been appointed as interim.

The Rev. Jocelyn Gardner Spencer was given the floor to provide an update on the Connecticut, Massachusetts and Rhode Island Conference unification, currently known as **Together**, **As One**. She gave some background information, fielded questions from the assembly, and referred to on-line documents and FAQs that are available to all.

The slate of nominees was presented. There being two nominees for the single General Synod Class of 2021 Delegate, Rev. Haverly called for a paper ballot bearing the names of Ms. Susan Waldron (Westfield) and Ms. Olivia Arsenault (East Woodstock.) Ballots were counted by Ms. Hubbell and Ms. Logee-Savoie, and Ms. Arsenault's name was moved forward onto the slate. Rev. Haverly called for the nomination of a lay member on the Windham Association Council. There being no further nominations, Rev. Spencer moved, with a second by Ms. Waldron, to accept the slate of officers, council members and Synod delegates. Upon voting, the motion PASSED.

Rev. Doyle presented the **proposed budget** for 2018-2019, noting a change in dues income based on changes in local church census. A motion to accept was made by Mr. Williams with a second by Ms. Kathleen Brown. Upon voting, the motion PASSED.

Rev. Haverly thanked East Woodstock Congregational for their hospitality and, there being no other business to come before the assembly, a motion was made by Mr. Williams and seconded by Rev. Caronna to **adjourn** following worship. Upon voting, the motion PASSED. The Rev. Dr. Susan Foster led evening worship and the assembly departed at 8:15 p.m.
